1) Polish language courses organized at our university, free of charge. The courses take place during whole academic year. There are 2 groups, depending on the level. In each semester (winter and summer) starts beginner level course (A1). There are 30 hours of the course during one semester. One week before semester starts Foreign Language Centre sets dates of courses.

- 4. Termination of the agreement

This Collaboration Agreement may be terminated on the following grounds:

- End of stipulated period of validity.
- · Mutual agreement between the parties.
- Written notice of termination with 6 months in advance, provided the termination shall not become effective until the end of the stay of the students enrolled in both institutions on the date of notification.
